

Ligonier Township Supervisors

Special Meeting

May 1, 2014

The Supervisors of Ligonier Township met in special session at 3:30 pm for a meeting advertised to open road material bids for 2014. Chairman Paul Knupp took roll call. Present were Chairman Paul Knupp and Timothy R. Komar. Scott Matson was absent.

Timothy Komar stated that all bids for #8 stone and E3M Oil are to include quantities for Ligonier Borough also.

Timothy Komar stated that all asphalt is purchased FOB and Ligonier Township reserves the right to dismiss the lowest bid because the cost differential of hauling is greater than the price difference.

A motion was made by Timothy Komar and seconded by Paul Knupp to accept the lowest responsible bidder. Komar requested that it be noted that the asphalt is not delivered due to the quantities at the time of delivery. The hauling to the lowest bidder would make our price that much more over and he requested that we use Hanson Aggregates for the Asphalt. He also stated that a spreadsheet would be available at the next meeting for public review. Final approval will be done at the next supervisors meeting.

A motion was made by Timothy Komar and seconded by Paul Knupp to adjourn the meeting at 4:00 pm. Motion carried.
